# Panel 4 | The Direction of Traffic in Competition Policy Thinking

The Conference closes with this Panel focusing on emerging new enforcement policies in response to changes in the political and economic landscape in the EU and the US (anti-subsidy rules, actions vs dominant firms, merger review, digital markets practice) and to the necessary revisions that are taking place to update existing policy instruments to ensure that they are fit for purpose (e.g., the Horizontal Guidelines, Vertical Guidelines, the Market Definition Notice, Regulation 1/2003, the establishment of the DMA Task Force, new guidance on Article 102 enforcement policy). The format is based on three presentations summarising global, EU and US trends, followed by a Panel made up of National key Competition Authorities and academic debating the merits of these policies.

#### HOW TO ATTEND

Conference registration occurs through the **Chillin' Competition website**, using the facilities of **Eventbrite** at Ithaca Competition Summit.

The fees are set at a level only to cover organisational costs, namely, €250 for practitioners and €50 for currently enrolled students on competition law courses in any part of the world. Seating is limited strictly to 120 participants. Oxford University Press has kindly offered to publish the conference papers in its Journal of Economic European Competition Law & Practice (JECLAP) publication.

As accomodation is a premium in the summer months, you should book your accomodation as soon as possible. There are a number of smaller hotels, apartments and AirBnB options available.

#### HOW TO GET THERE

To reach the Ionian island of Ithaca, you will need to arrive by either ferry or sea taxi as there is no airport on the island itself. The closest airport is on the neighbouring island of **Kefalonia** (Argostoli airport), which receives daily domestic flights from Athens (Aegean Airlines), and the trip takes 45 minutes. There are also many direct scheduled flights in summer from European airports to Kefalonia (including London, Amsterdam, Madrid, Rome and various airports in Germany), as well as charter flights. After arriving by plane to Kefalonia and then a taxi to the port of Sami, visitors can take the scheduled ferry service or arrange for a water taxi from Sami to Ithaca, or take the ferry to Ithaca from the port of Kyllini.

The other airports worth considering are **Preveza** and **Araxos**, both on the mainland, and the nearby island of **Zakynthos**. These smaller regional airports have a number of charter flights during the summer season. From Preveza, one can drive easily over the bridge to the island of **Lefkada** and ferry to Ithaca, while from Araxos in the Peloponnese one can drive to the ports of **Patra** or **Kyllini**, which has a daily ferry services to Ithaca. From Zakynthos, which hosts many international flights, one can take the ferry to Ithaca via Kefalonia.

Alternatively, one can drive from Athens airport to the west coast of the mainland and take a ferry from the ports of Patra (240kms), Astakos (320kms) or Kyllini (320kms). A ferry service also connects the islands of Lefkada to Ithaca.

The ports of Patra and Kyllini are close to the airport of Araxos in the Peloponnese, while the port of Astakos is close to the airport of Preveza. From Lefkada, one leaves for Ithaca from the ports of Nidri or Vassiliki.

If you are interested in some island hopping, there is a flight service (Sky Express) from Corfu to Kefalonia, and a hydrofoil island hopping ferry service which covers the Ionian islands of Corfu, Paxos, Ithaca, Kefalonia and Zakynthos. As Ithaca can be readily accessed from the respective islands of Kefalonia and Lefkada and Zakynthos, the hiring of a car to take advantage of island hopping possibilities is often seen as a useful option.
